

DSWD DROMIC Report on the Fire Incident in Brgy. Malapoc, Balasan, Iloilo

28 June 2025, 6AM

I. Situation Overview

On 24 June 2025 at around 8:00 AM, a fire broke out in Brgy. Malapoc, Balasan, Iloilo. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 8:30 AM. A residential structure was completely destroyed, displacing the family that lived there.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office in Region VI, immediately provided relief assistance to address the needs of the affected family.

One (1) family or five (5) persons were affected in **Brgy. Malapoc, Balasan, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Malapoc, Balasan, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,862.40** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
