

DSWD DROMIC Report on the Fire Incident in Brgy. Mandalagan, Bacolod City

27 June 2025, 6PM

I. Situation Overview

On 13 June 2025 at around 10:32 AM, a fire incident occurred at Estancia, Brgy. Mandalagan, Bacolod City, Negros Occidental. Due to the incident, four (4) individuals were affected and caused damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, together with the Local Government Unit (LGU) of Bacolod City, immediately provided food and non-food items (FNIs) to address the needs of the affected individuals.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Mandalagan, Bacolod City (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives in Brgy. Mandalagan, Bacolod City (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Mandalagan, Bacolod City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,912.00** worth of assistance was provided to the affected family; of which, **P4,622.00** from **DSWD** and **P4,290.00** from the **LGU** (see Annex D).
