

DSWD DROMIC Report on the Fire Incident in Brgy. Masgrau, Jamindan, Capiz 25 June 2025, 6AM

I. Situation Overview

On 22 June 2025 at around 1:32 PM, a fire incident occurred in Brgy. Masgrau, Jamindan, Capiz. The fire was declared out at around 2:00 PM.

One (1) family or five (5) persons were affected in **Brgy. Masgrau, Jamindan, Capiz** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Masgrau, Jamindan, Capiz** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,614.32** worth of assistance was provided to the affected family; of which, **₱6,614.32** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
