

DSWD DROMIC Report on the Fire Incident in Brgy. Monamon Sur, Bauko, Mountain Province

15 June 2025, 6AM

I. Situation Overview

On 01 May 2025 at around 5:30 AM, a fire broke out at Sitio Dodoan, Brgy. Monamon Sur, Bauko, Mountain Province. It was declared a fire out at around 6:00 AM. The fire completely destroyed a residential structure, displacing a family who were generously offered temporary accommodation by a neighbor at a vacant house while they waited for the reconstruction of their own home.

Two family members sustained injuries and were given first aid by the responders before being referred to the nearest hospital for further treatment. The rest of the family were assessed and provided with first aid for smoke inhalation.

II. Status of Affected Areas and Population

One (1) family or seven (7) persons were affected in Brgy. Monamon Sur, Bauko, Mountain Province (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **seven (7) persons** temporarily stayed with their neighbor (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Monamon Sur, Bauko, Mountain Province** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱37,346.32 worth of assistance was provided to the affected family; of which, ₱34,946.32 from DSWD and ₱2,400.00 from the Local Government Unit (LGU) (see Annex D).
