

DSWD DROMIC Report on the Fire Incident in Brgy. Nato, La Castellana, Negros Occidental

24 June 2025, 6PM

I. Situation Overview

On 22 May 2025 at around 11:00 PM, a fire incident occurred in Brgy. Nato, La Castellana, Negros Occidental. Due to the incident, three (3) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, together with the Local Government Unit (LGU) of La Castellana, Negros Occidental, provided food and non-food items (FNIs) to support the immediate needs of the affected individuals.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in Brgy. Nato, La Castellana, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Nato, La Castellana, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P9,268.00** worth of assistance was provided to the affected family; of which, **P4,268.00** from **DSWD** and **P5,000.00** from the **LGU** (see Annex D).
