

## **DSWD DROMIC Report on the Fire Incident in Brgy. New Gumiad, Dupax del Norte, Nueva Vizcaya**

22 June 2025, 6AM

### **I. Situation Overview**

On 23 May 2025, a fire broke out in Brgy. New Gumiad, Dupax del Norte, Nueva Vizcaya. One residential structure was completely destroyed, displacing a family who has since sought temporary shelter with relatives.

### **II. Status of Affected Areas and Population**

**One (1) family or four (4) persons** were affected in **Brgy. New Gumiad, Dupax del Norte, Nueva Vizcaya** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

**One (1) family or four (4) persons** are temporarily staying with their relatives (see Annex B).

### **IV. Damaged Houses**

A total of **one (1) house** was **totally damaged** in **Brgy. New Gumiad, Dupax del Norte, Nueva Vizcaya** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱5,753.00** worth of assistance was provided to the affected family; of which, **₱4,603.00** from **DSWD** and **₱1,150.00** from the **Local Government Unit (LGU)** (see Annex D).
