I. Situation Overview

On 14 June 2025 at around 11:10 AM, a fire incident occurred in Brgy. Parag-um, Carigara, Leyte. The fire was declared out at around 11:40 AM.

One (1) house was **totally** damaged in **Brgy. Parag-um, Carigara, Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱18,987.15** worth of assistance was provided by **DSWD** to the affected family in **Brgy. Parag-um, Carigara, Leyte** (see Annex D).
