

# DSWD DROMIC Report on the Fire Incident in Brgy. Pinagbirayan Malaki, Paracale, Camarines Norte

01 June 2025, 6AM

## I. Situation Overview

On 20 May 2025 at around 10:15 AM, a fire incident occurred at Purok 1, Brgy. Pinagbirayan Malaki, Paracale, Camarines Norte. Due to the incident, nine (9) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) V, together with the Local Government Unit (LGU) of Paracale, Camarines Norte, immediately provided food and non-food items (FNIs) to address the needs of the affected individuals.

A total of **two (2) families** or **nine (9) persons** were affected in **Brgy. Pinagbirayan Malaki, Paracale, Camarines Norte** (see Annex A).

#### **Outside Evacuation Center**

A total of **two (2) families** or **nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Pinagbirayan Malaki, Paracale, Camarines Norte** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱13,192.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
