

DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion 6, City of Cabadbaran, Agusan del Norte

28 June 2025, 6AM

I. Situation Overview

On 31 May 2025 at around 8:58 PM, a fire broke out at Purok 3, Brgy. Poblacion 6, City of Cabadbaran, Agusan del Norte. The Bureau of Fire Protection (BFP) promptly responded to the scene and successfully extinguished the fire by 9:30 PM. The fire destroyed residential structures, resulting in the displacement of two families. No injuries or casualties were reported.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office in Region XIII and in coordination with the Local Government Unit (LGU) of the City of Cabadbaran, immediately provided relief assistance to address the needs of the affected families.

II. Status of Affected Areas and Population

A total of **two (2) families** or **10 persons** were affected in **Brgy. Poblacion 6, City of Cabadbaran, Agusan del Norte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **one (1) family** or **4 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) was totally damaged and one (1) was partially damaged in Brgy. Poblacion 6, City of Cabadbaran, Agusan del Norte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,538.88** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
