I. Situation Overview

On 06 March 2025 at around 4:00 PM, a fire incident occurred in Brgy. Poblacion, San Miguel, Bulacan.

II. Status of Affected Areas and Population

A total of **two (2) families** or **ten (10) persons** were affected in **Brgy. Poblacion**, **San Miguel, Bulacan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **10 persons** are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** is **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Poblacion, San Miguel, Bulacan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P24,000.00** worth of assistance was provided to the affected families; of which, **P15,000.00** from **DSWD** and **P9,000.00** from the **Local Government Unit (LGU)** (see Annex D).
