

## DSWD DROMIC Report on the Fire Incident in Brgy. Salvacion Habog-Habog, Molo, Iloilo City

24 June 2025, 6PM

### I. Situation Overview

On 10 June 2025 at around 3:20 PM, a fire incident occurred in Brgy. Salvacion Habog-Habog, Molo, Iloilo City. The fire was declared out at around 3:31 PM. Due to the incident, eight (8) individuals were affected and caused significant damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, together with the Local Government Unit (LGU) of Iloilo City, immediately provided food and non-food items to address the needs of the affected individuals.

### II. Status of Affected Areas and Population

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy. Salvacion Habog-Habog, Molo, Iloilo City** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

A total of **two (2) families** or **eight (8) persons** temporarily stayed with their relatives in Brgy. Salvacion Habog-Habog, Molo, Iloilo City (see Annex B).

### IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** is **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Salvacion Habog-Habog, Molo, Iloilo City** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱13,508.40** worth of assistance was provided to the affected families; of which, **₱7,022.00** from **DSWD** and **₱6,486.40** from the **LGU** (see Annex D).
