

DSWD DROMIC Report on the Fire Incident in Brgy. San Jose Mesulo, Arayat, Pampanga

23 June 2025, 6AM

I. Situation Overview

On 23 May 2025 at around 1:10 PM, a fire broke out in Brgy. San Jose Mesulo, Arayat, Pampanga. The fire completely destroyed a residential structure, displacing the family living there. The family has since sought temporary shelter with relatives.

In response, the Department of Social Welfare and Development, through its Field Office (FO) in Region III and in coordination with the Local Government Unit (LGU) of Arayat, Pampanga, has promptly provided assistance to address the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or six (6) persons were affected in Brgy. San Jose Mesulo, Arayat, Pampanga (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** are still temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. San Jose Mesulo, Arayat, Pampanga** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱15,000.00** worth of assistance was provided to the affected family; of which, **₱10,000.00** from **DSWD** and **₱5,000.00** from the **LGU** (see Annex D).
