

DSWD DROMIC Report on the Fire Incident in Brgy. San Juan, Pontevedra, Negros Occidental

11 June 2025, 6AM

I. Situation Overview

On 31 May 2025 at around 5:45 PM, a fire broke out in Brgy. San Juan, Pontevedra, Negros Occidental. The fire destroyed a residential structure, resulting in the displacement of a family, who sought temporary shelter with their relatives.

II. Status of Affected Areas and Population

One (1) family or **five (5) persons** were affected in **Brgy. San Juan, Pontevedra, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives (see Annex B). The family has since returned home after repairing the damage to their house.

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. San Juan, Pontevedra, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱7,610.00 worth of assistance was provided to the affected family; of which, ₱4,610.00 from DSWD and ₱3,000.00 from the Local Government Unit (LGU) (see Annex D).
