

DSWD DROMIC Report on the Fire Incident in Brgy. San Nicolas, San Esteban, Ilocos Sur

18 June 2025, 6AM

I. Situation Overview

On 17 May 2025 at around 10:30 PM, a fire incident occurred in Brgy. San Nicolas, San Esteban, Ilocos Sur. Due to the incident, three (3) individuals were affected and caused damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) I, together with the Local Government Unit (LGU) of San Esteban, Ilocos Sur, immediately provided food and non-food items (FNIs) and financial assistance (FA) to address the needs of the affected individuals.

One (1) family or three (3) persons were affected in **Brgy. San Nicolas, San Esteban, Ilocos Sur** (see Annex A).

III. Damaged Houses

One (1) house was **partially damaged** in **Brgy. San Nicolas, San Esteban, Ilocos Sur** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱27,082.91** worth of assistance was provided to the affected families; of which, **₱21,332.91** from **DSWD** and **₱5,750.00** from the **LGU** (see Annex C).
