

DSWD DROMIC Report on the Fire Incident in Brgy. San Pablo, Diadi, Nueva Vizcaya

22 June 2025, 6AM

I. Situation Overview

On 01 June 2025 at around 12:20 PM, a fire broke out in Brgy. San Pablo, Diadi, Nueva Vizcaya. A residential structure was completely destroyed, displacing the homeowner who lived there.

In a Facebook post of the Municipal Social Welfare and Development Office (MSWDO) of the Local Government Unit (LGU) of Diadi, Nueva Vizcaya, the fire is believed to have started from an ember left unattended in the cookstove. The homeowner thought it had already been put out, but a strong gust of wind rekindled the flames, causing the fire to spread quickly and destroy the house.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. San Pablo, Diadi, Nueva Vizcaya** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,954.03** worth of assistance was provided to the affected person; of which, **₱2,416.26** from **DSWD** and **₱8,537.77** from the **LGU** (see Annex D).
