

# DSWD DROMIC Report on the Fire Incident in Brgy. Santa Barbara, Igbaras, Iloilo

26 June 2025, 6PM

## I. Situation Overview

On 18 June 2025 at around 10:51 AM, a fire incident occurred at Sitio Bululakaw, Brgy. Santa Barbara, Igbaras, Iloilo. The fire was declared out at around 11:15 AM. Due to the incident, two (2) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, in close coordination with the Local Government Unit (LGU) of Igbaras, Iloilo, immediately provided food and non-food items (FNIs) to support the needs of the affected individuals.

## V. Cost of Humanitarian Assistance Provided

A total of **₱10,482.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
