

DSWD DROMIC Report on the Fire Incident in Brgy. Santa Rita, Maasin, Iloilo

10 June 2025, 6PM

I. Situation Overview

On 28 May 2025 at around 12:05 PM, a fire incident occurred in Brgy. Santa Rita, Maasin, Iloilo. The fire was declared out at around 1:00 PM.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) in Region VI, together with the Local Government Unit (LGU) of Maasin, Iloilo, immediately provided food and non-food items (FNIs) to support the immediate needs of the affected family.

One (1) family or four (4) persons were affected in **Brgy. Santa Rita, Maasin, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Santa Rita, Maasin, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,895.00** worth of assistance was provided to the affected family composed of **₱10,672.00** from **DSWD** and **₱1,223.00** from the **Local Government Unit (LGU)** (see Annex D).
