

# DSWD DROMIC Report on the Fire Incident in Brgy. Sto. Niño Norte, Arevalo, Iloilo City

24 June 2025, 6PM

#### I. Situation Overview

On 09 June 2025 at around 8:40 AM, a fire incident occurred in Brgy. Sto. Niño Norte, Arevalo, Iloilo City. The fire was declared out at around 8:50 AM. Due to the incident, five (5) individuals were affected and caused damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, together with the Local Government Unit (LGU) of Iloilo City, immediately provided food and non-food items (FNIs) to address the needs of the affected individuals.

One (1) family or five (5) persons temporarily stayed with their relatives or friends (see Annex B).

# IV. Damaged Houses

One (1) house was partially damaged in Brgy. Sto. Niño Norte, Arevalo, Iloilo City (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **₱13,428.00** worth of assistance was provided to the affected family; of which, **₱10,050.00** from **DSWD** and **₱3,378.00** from the **LGU** (see Annex D).
