

DSWD DROMIC Report on the Fire Incident in Brgy. Suay, City of Himamaylan, Negros Occidental

10 June 2025, 6PM

I. Situation Overview

On 23 May 2025 at around 4:15 AM, a fire incident occurred in Purok RD, Brgy. Suay, City of Himamaylan, Negros Occidental. Due to the incident, 10 individuals were affected and caused damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, together with the Local Government Unit (LGU) of the City of Himamaylan, immediately provided food and non-food items (FNIs) to address the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of two (2) families or 10 persons were affected in Brgy. Suay, City of Himamaylan, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **10 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) is totally damaged and one (1) is partially damaged in Brgy. Suay, City of Himamaylan, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱28,372.00 worth of assistance was provided to the affected families composed of ₱13,372.00 from DSWD and ₱15,000.00 from the Local Government Unit (LGU) (see Annex D).
