

DSWD DROMIC Report on the Fire Incident in Brgy. Taft, Tapaz, Capiz

25 June 2025, 6PM

I. Situation Overview

On 14 June 2025 at around 11:30 PM, a fire incident occurred in Brgy. Taft, Tapaz, Capiz. The fire was declared out at around 12:00 AM. Due to the incident, four (4) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, together with the Local Government Unit (LGU) of Tapaz, Capiz, immediately provided food and non-food items (FNIs) to address the needs of the affected individuals.

One (1) family or **four (4) persons** were affected in **Brgy. Taft, Tapaz, Capiz** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Taft, Tapaz, Capiz** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱4,272.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
