

DSWD DROMIC Report on the Fire Incident in Brgy. Talubangi, City of Kabankalan, Negros Occidental

19 June 2025, 6AM

I. Situation Overview

On 04 June 2025 at around 3:30 PM, a fire occurred in Brgy. Talubangi, City of Kabankalan, Negros Occidental. The fire resulted in the partial destruction of one (1) residential structure, leading to the displacement of five (5) individuals.

In response, the Department of Social Welfare and Development (DSWD) Field Office (FO) VI, together with the Local Government Unit (LGU) of City of Kabankalan, Negros Occidental, promptly provided relief assistance consisting of both food and non-food items (FNIs) to support the immediate needs of the affected individuals.

II. Status of Affected Areas and Population

One (1) family or five (5) persons were affected in **Brgy. Talubangi, City of Kabankalan, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Talubangi, City of Kabankalan, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,598.00** worth of assistance was provided to the affected families; of which, **₱6,198.00** from **DSWD** and **₱5,400.00** from the **LGU** (see Annex D).
