

## **DSWD DROMIC Report on the Fire Incident in Brgy. Tapaz, Santa Josefa, Agusan del Sur**

25 June 2025, 6AM

### **I. Situation Overview**

On 03 April 2025 at around 1:00 AM, a fire incident occurred at Purok 1, Brgy. Tapaz, Santa Josefa, Agusan del Sur. The fire was declared out at around 4:00 AM.

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Tapaz, Santa Josefa, Agusan del Sur** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱22,646.50** worth of assistance was provided to the affected families; of which, **₱12,646.50** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
