I. Situation Overview

On 10 June 2025 at around 9:00 AM, a fire incident occurred at Purok Malinhao, Brgy. Tiglawigan, Cadiz City, Negros Occidental.

A total of **₱16,322.00** worth of assistance was provided to the affected families; of which, **₱4,622.00** from **DSWD** and **₱11,700.00** from the **Local Government Unit (LGU)** (see Annex D).
