

DSWD DROMIC Report on the Fire Incident in Brgy. Zone 1, Cadiz City, Negros Occidental

30 June 2025, 6PM

I. Situation Overview

On 08 June 2025 at around 9:24 PM, a fire incident occurred at Purok Masinadyahon, Brgy. Zone 1, Cadiz City, Negros Occidental. Due to the incident, six (6) individuals were affected and caused damage to their houses.

II. Status of Affected Areas and Population

One (1) family or six (6) persons were affected in Brgy. Zone 1, Cadiz City, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Zone 1, Cadiz City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱10,122.00 worth of assistance was provided to the affected families; of which, ₱4,622.00 from DSWD and ₱5,500.00 from the Local Government Unit (LGU) (see Annex D).
