

# DSWD DROMIC Report on the Fire Incident in Brgy. Zone 6, Cadiz City, Negros Occidental

30 June 2025, 6PM

#### I. Situation Overview

On 07 June 2025 at around 2:00 PM, a fire incident occurred at Purok Lison, Brgy. Zone 6, Cadiz City, Negros Occidental. The fire resulted in the displacement and damages to the properties of three (3) families.

### II. Status of Affected Areas and Population

A total of three (3) families or 10 persons were affected in Brgy. Zone 6, Cadiz City, Negros Occidental (see Annex A).

## III. Status of Displaced Population

#### **Outside Evacuation Center**

A total of **three (3) families** or **10 persons** temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

A total of three (3) houses were damaged; of which, one (1) is totally damaged and two (2) are partially damaged in Brgy. Zone 6, Cadiz City, Negros Occidental (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **P41,332.00** worth of assistance was provided to the affected families; of which, **P6,232.00** from **DSWD** and **P35,100.00** from the **Local Government Unit (LGU)** (see Annex D).
