

DSWD DROMIC Report on the Strong Wind Incident in Bingawan, Iloilo

18 June 2025, 6PM

I. Situation Overview

On 02 June 2025 at around 4:00 PM, a strong wind incident occurred in several barangays in the municipality of Bingawan, lloilo that caused damage to residential houses.

A total of **79 families** or **378 persons** were affected in **three (3) barangays** in **Bingawan**, **Iloilo** (see Annex A).

III. Damaged Houses

A total of **33 houses** were **partially damaged** in **Bingawan**, **Iloilo** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱49,138.00** worth of assistance was provided by **DSWD** to the affected families (see Annex C).
