

DSWD DROMIC Report on the Strong Wind Incident in Brgy. Maltana, Tampakan, South Cotabato

03 June 2025, 6AM

I. Situation Overview

On 07 May 2025 at around 3:00 PM, a strong wind incident caused by Easterlies was experienced in Brgy. Maltana, Tampakan, South Cotabato. Several houses were damaged due to the effects of the weather, displacing 10 individuals in the area.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) XII, in close coordination with the Local Government Unit (LGU) of Tampakan, South Cotabato, provided food and non-food items (FNIs) to address the needs of the affected individuals

II. Status of Affected Areas and Population

A total of **nine (9) families** or **45 persons** were affected in **Brgy. Maltana**, **Tampakan, South Cotabato** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **two (2) families** or **10 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of nine (9) houses were damaged; of which, two (2) are totally damaged and seven (7) are partially damaged in Brgy. Maltana, Tampakan, South Cotabato (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **27,900.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
