

## **DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Daramuangan Norte, San Mateo, Isabela**

29 June 2025, 6AM

### **I. Situation Overview**

On 03 June 2025, a fire broke out in Brgy. Daramuangan Norte, San Mateo, Isabela. The fire completely destroyed a residential structure, displacing the family that lived there. The family has since sought temporary shelter with relatives within the barangay.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region II and in coordination with the Local Government Unit (LGU) of San Mateo, Isabela, has promptly provided assistance to address the immediate needs of the affected family.

### **II. Status of Affected Areas and Population**

**One (1) family or three (3) persons** were affected in **Brgy. Daramuangan Norte, San Mateo, Isabela** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

**One (1) family or three (3) persons** are still temporarily staying with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was totally damaged in **Brgy. Daramuangan Norte, San Mateo, Isabela** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱20,925.60** worth of assistance was provided to the affected family; of which, **₱5,925.60** from **DSWD** and **₱15,000.00** from the **LGU** (see Annex D).
