

# **DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Dontogan, Baguio City**

20 June 2025, 6AM

## **I. Situation Overview**

On 18 April 2025 at around 3:40 AM, a fire broke out at Foggy Hill Talco Compound, Brgy. Dontogan, Baguio City. The fire was extinguished and declared out at around 4:20 AM. It completely destroyed the residential structure, displacing two (2) individuals. They also sustained injuries during the incident and were brought to the Baguio General Hospital and Medical Center for medical treatment. The affected individuals initially sought temporary shelter with relatives in a nearby barangay.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office Cordillera Administrative Region (FO CAR), together with the Local Government Unit (LGU) of Baguio City, promptly provided relief assistance consisting of both food and non-food items (FNIs), as well as financial assistance (FA), to support the immediate needs of the affected individuals.

**One (1) house** was **totally damaged** in **Brgy. Dontogan, Baguio City** (see Annex C).

## **V. Cost of Humanitarian Assistance Provided**

A total of **₱41,395.80** worth of assistance was provided to the affected family; of which, **₱16,395.80** from **DSWD**, and **₱25,000.00** from the **LGU** (see Annex D).
