## DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Masical, Santo Niño (Faire), Cagayan

23 June 2025, 6AM

### I. Situation Overview

On 11 June 2025 at around 2:34 PM, a fire broke out in Brgy. Masical, Santo Niño (Faire), Cagayan. The fire completely destroyed a residential structure, displacing a family living there. The family has since sought temporary shelter with relatives within the barangay.

In response, the Department of Social Welfare and Development, through its Field Office in Region II and in coordination with the Local Government Unit (LGU) of Santo Niño (Faire), Cagayan, has promptly provided assistance to address the immediate needs of the affected family.

### II. Status of Affected Areas and Population

**One (1) family or three (3) persons** were affected in **Brgy. Masical, Santo Niño (Faire), Cagayan** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family or three (3) persons** are still temporarily staying with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Masical, Santo Niño (Faire), Cagayan** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱21,827.28** worth of assistance was provided to the affected family; of which, **₱16,827.28** from **DSWD** and **₱5,000.00** from the **LGU** (see Annex D).
