

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Pinsao Proper, Baguio City

28 June 2025, 6PM

I. Situation Overview

On 26 December 2024 at around 12:30 PM, a fire incident occurred at Purok 4, Brgy. Pinsao Proper, Baguio City. The fire was declared out at around 2:00 PM. Due to the incident, five (5) individuals were affected and caused damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office Cordillera Administrative Region (FO CAR), together with the Local Government Unit (LGU) of Baguio City, immediately provided food and non-food items (FNIs) and financial assistance (FA) to the affected individuals.

One (1) family or **five (5) persons** were affected in **Brgy. Pinsao Proper, Baguio City** (see Annex A).

III. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Pinsao Proper, Baguio City** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱32,054.60** worth of assistance was provided to the affected family; of which, **₱17,054.60** from **DSWD** and **₱15,000.00** from the **LGU** (see Annex C).
