

## **DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Poblacion District V, Barugo, Leyte**

29 June 2025, 6AM

### **I. Situation Overview**

On 23 May 2025 at around 10:28 AM, a fire broke out in Brgy. Poblacion District V, Barugo, Leyte. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 10:49 AM.

A residential structure was completely destroyed, displacing the family that lived there. The family has since sought temporary shelter with a relative. Fortunately, no injuries or casualties were reported.
