

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Poblacion I, Capoocan, Leyte

05 June 2025, 6PM

I. Situation Overview

On 11 May 2025 at around 8:39 AM, a fire broke out in Brgy. Poblacion I, Capoocan, Leyte. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 8:43 AM. One residential structure was completely destroyed, displacing a resident who has since sought temporary shelter with relatives.

One (1) house was **totally damaged** in **Brgy. Poblacion I, Capoocan, Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱15,105.05** worth of assistance was provided by **DSWD** to the affected family / person (see Annex D).
