

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Puguis, La Trinidad, Benguet

28 June 2025, 6PM

I. Situation Overview

On 10 November 2024 at around 1:00 AM, a fire incident occurred at Sitio Puguis Proper, Brgy. Puguis, La Trinidad, Benguet. The fire was declared out at around 5:13 AM. Due to the incident, 134 individuals were affected and caused significant damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office Cordillera Administrative Region (FO CAR), together with the Local Government Unit (LGU) of La Trinidad, Benguet and other partners, provided relief assistance to support the immediate needs of the affected individuals.

II. Status of Affected Areas and Population

A total of **48 families** or **134 persons** were affected in **Brgy. Puguis, La Trinidad, Benguet** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **22 families** or **59 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **seven (7) houses** were damaged; of which, **four (4)** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. Puguis, La Trinidad, Benguet** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱500,334.60 worth of assistance was provided to the affected families; of which, ₱246,829.60 from DSWD, ₱26,505.00 from the LGU, and ₱227,000.00 from other Partners (see Annex D).
