

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. San Roque, Santa Fe, Leyte

20 June 2025, 6AM

I. Situation Overview

On 16 May 2025 at around 4:27 PM, a fire incident occurred in Brgy. San Roque, Santa Fe, Leyte. The fire was declared out at around 5:30 PM. Due to the incident, eight (8) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VIII, in coordination with the Local Government Unit (LGU) of Santa Fe, Leyte, promptly provided food and non-food items (FNIs) and financial assistance (FA) to address the needs of the affected individuals.

One (1) family or eight (8) persons were affected in **Brgy. San Roque, Santa Fe, Leyte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or eight (8) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. San Roque, Santa Fe, Leyte** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱18,987.65** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
