

DSWD DROMIC Terminal Report on the Fire incident in Brgy. Kagingkingan, Anahawan, Southern Leyte

28 June 2025, 6PM

I. Situation Overview

On 07 June 2025 at around 9:28 AM, a fire broke out in Brgy. Kagingkingan, Anahawan, Southern Leyte. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 10:37 AM. A residential structure was completely destroyed, displacing three (3) individuals. No injuries or casualties were reported.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VIII, together with the Local Government Unit (LGU) of Anahawan, Southern Leyte, immediately provided food and non-food items (FNIs) and financial assistance (FA) to address the needs of the affected individuals.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in **Brgy. Kagingkingan, Anahawan, Southern Leyte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Kagingkingan, Anahawan, Southern Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱33,070.00** worth of assistance was provided to the affected family; of which, **₱18,070.00** from **DSWD**, and **₱15,000.00** from the **LGU** (see Annex D).
