

## **DSWD DROMIC Terminal Report on the Strong Wind Incident in Brgy. Nasunogan, Dao, Capiz**

08 July 2025, 6PM

### **I. Situation Overview**

On 01 June 2025 at around 5PM, strong winds were experienced in Brgy. Nasunogan, Dao, Capiz. Several residential houses were destroyed, displacing 42 individuals who sought temporary shelter with their relatives. No casualties were reported.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI and in close coordination with the Local Government Unit (LGU) of Dao, Capiz, immediately provided food and non-food items (FNIs) to address the urgent needs of the affected individuals.

### **II. Status of Affected Areas and Population**

A total of **12 families** or **42 persons** were affected in **Brgy. Nasunogan, Dao, Capiz** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

A total of **two (2) families** or **seven (7) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

A total of **12 houses** were damaged; of which, **two (2)** are **totally damaged** and **10** are **partially damaged** in **Brgy. Nasunogan, Dao, Capiz** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱51,228.80** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
