

## DSWD DROMIC Report #1 on the Clan Feud Incident in Brgy. Kilangan, Pagalungan, Maguindanao del Sur as of 16 July 2025, 6PM

### I. Situation Overview

On 08 July 2025 at around 4:00 PM, a clan feud or “rido” involving two (2) warring families occurred in Brgy. Kilangan, Pagalungan, Maguindanao del Sur. The conflict resulted in several houses being burned and in the displacement of families.

### II. Status of Affected Areas and Population

A total of **479 families** or **2,395 persons** are affected in **Brgy. Kilangan, Pagalungan, Maguindanao del Sur** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

There are **479 families** or **2,395 persons** temporarily staying with their relatives or friends (see Annex B).

### IV. Damaged Houses

A total of **three (3) houses** were **partially damaged** in **Brgy. Kilangan, Pagalungan, Maguindanao del Sur** (see Annex C).
