

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Cadac-an, Abuyog, Leyte

as of 16 July 2025, 6PM

I. Situation Overview

On 30 June 2025 at around 10:00 AM, a fire broke out at Brgy. Cadac-an, Abuyog, Leyte. The Bureau of Fire Protection (BFP) promptly responded to the scene and was able to extinguish the fire by 3:21 PM. Two (2) residential structures were damaged, displacing families who have since sought temporary shelter with relatives. No injuries or casualties were reported.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VIII, in coordination with the Local Government Unit (LGU) of Abuyog, Leyte, provided relief assistance to address the immediate needs of the affected families.

II. Status of Affected Areas and Population

A total of two (2) families or nine (9) persons are affected in Brgy. Cadac-an, Abuyog, Leyte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are two (2) families or nine (9) persons temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) was totally damaged and one (1) was partially damaged in Brgy. Cadac-an, Abuyog, Leyte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P15,000.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
