

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Cautod, Sta. Margarita, Samar

as of 19 July 2025, 6PM

I. Situation Overview

On 11 July 2025 at around 9:00 PM, a fire broke out in Brgy. Cautod, Sta. Margarita, Samar. Two (2) residential structures were completely destroyed, displacing a family who has since sought temporary shelter with relatives or friends. No injuries or casualties have been reported.

A total of nine (9) families or 18 persons are affected in Brgy. Cautod, Sta. Margarita, Samar (see Annex A).

III. Status of Displaced Population

There are **nine** (9) **families or 18 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were totally damaged in Brgy. Cautod, Sta. Margarita, Samar (see Annex C).

A total of **P21,376.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
