

## DSWD DROMIC Report #1 on the Fire Incident in Brgy. Lapinig Del Norte (Pob.), Lapinig, Northern Samar as of 19 July 2025, 6PM

### I. Situation Overview

On 12 June 2025 at around 8:45 PM, a fire incident occurred in Brgy. Lapinig Del Norte (Pob.), Lapinig, Northern Samar. The fire was declared out at around 10:22 AM.
