



### III. Status of Displaced Population

#### a. Inside Evacuation Center

There are **three (3) families** or **15 persons** currently taking temporary shelter in **two (2) evacuation centers** in **Region III** (see Annex B).

#### b. Outside Evacuation Center

There are **1,023 families** or **3,029 persons** temporarily staying with their relatives or friends (see Annex D).

#### c. Total Displaced Population

There are **1,026 families** or **3,044 persons** still displaced in **Regions III** and **CAR** (see Annex E).

### IV. Damaged Houses

A total of **25 houses** were damaged in **Regions I, III, and CAR**; of which, **four (4)** were **totally damaged** and **21** were **partially damaged** (see Annex F).

### V. Cost of Humanitarian Assistance Provided

A total of **₱8,736,606.94** worth of assistance was provided to the affected families; of which, **₱8,432,822.51** from **DSWD** and **₱303,784.43** from the **Local Government Units (LGUs)** (see Annex G).
