

III. Status of Displaced Population

a. Inside Evacuation Center

There are **104 families** or **419 persons** currently taking temporary shelter in **three (3) evacuation centers** in **Regions III** and **NCR** (see Annex B).

b. Outside Evacuation Center

There are **21 families** or **76 persons** temporarily staying with their relatives or friends (see Annex D).

c. Total Displaced Population

There are **1,125 families** or **3,495 persons** still displaced in **Regions III**, **CAR**, and **NCR** (see Annex E).

IV. Damaged Houses

A total of **25 houses** were damaged; of which, **four (4)** were **totally damaged** and **21** were **partially damaged** in **Regions I**, **III**, and **CAR** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of **₱17,664,174.79** worth of assistance was provided to the affected families; of which, **₱17,341,441.86** from **DSWD** and **₱322,732.93** from the **Local Government Units (LGUs)** (see Annex G).
