

## **DSWD DROMIC Report #2 on the Fire Incident in Brgy. Cadac-an, Abuyog, Leyte** as of 05 August 2025, 6AM

### **I. Situation Overview**

On 30 June 2025 at around 10:00 AM, a fire broke out at Brgy. Cadac-an, Abuyog, Leyte. The Bureau of Fire Protection (BFP) promptly responded to the scene and was able to extinguish the fire by 3:21 PM. Two (2) residential structures were damaged, displacing families who have since sought temporary shelter with relatives. No injuries or casualties were reported.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VIII, in coordination with the Local Government Unit (LGU) of Abuyog, Leyte, provided relief assistance to address the immediate needs of the affected families.

A total of **two (2) families** or **nine (9) persons** are affected in **Brgy. Cadac-an, Abuyog, Leyte** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

There are **two (2) families** or **nine (9) persons** temporarily staying with their relatives (see Annex B).

### **IV. Damaged Houses**

A total of **two (2) houses** were damaged; of which, **one (1)** was **totally damaged** and **one (1)** was **partially damaged** in **Brgy. Cadac-an, Abuyog, Leyte** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱31,157.04** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
