

DSWD DROMIC Report #4 on the Effects of Southwest Monsoon and Tropical Depression “Bising” as of 05 July 2025, 6PM

I. Situation Overview

Issued on 04 July 2025, at 5:00 PM, “**Bising**” has exited the Philippine Area of Responsibility (PAR).

HAZARDS AFFECTING LAND AREAS

Heavy Rainfall Outlook

Refer to the Weather Advisory issued No. 11 at 5:00 PM today for the heavy rainfall outlook due to Tropical Depression (TD) “Bising” and the Southwest Monsoon.

Severe Winds

The Southwest Monsoon and the periphery of Bising will also bring strong to gale-force gusts over the following areas (especially in coastal and upland areas exposed to winds):

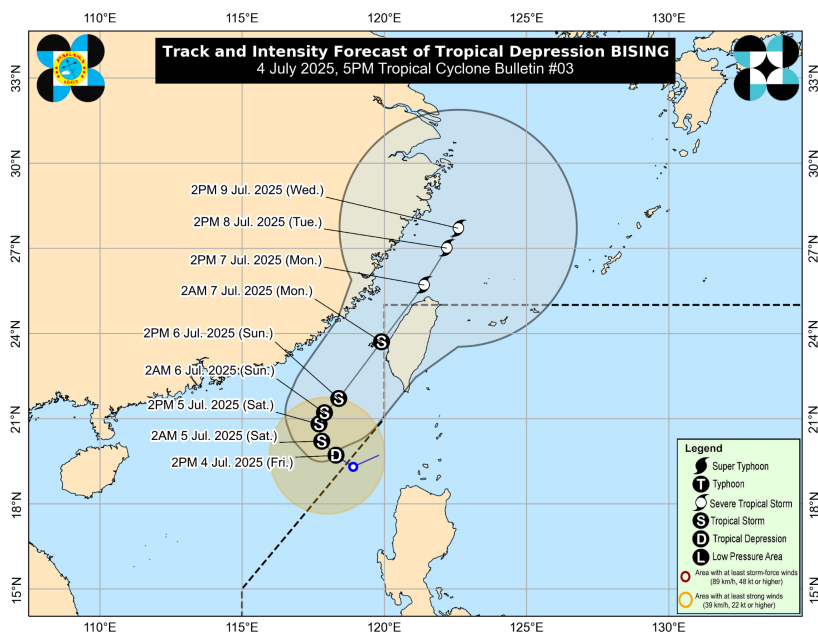
- **Today (4 July):** Ilocos Region, Isabela, the northern portion of Aurora, Zambales, Occidental Mindoro, Marinduque, Romblon, Palawan, and Antique.
- **Tomorrow (5 July):** the rest of Ilocos Norte, Ilocos Sur, La Union, Pangasinan, Isabela, the northern portion of Aurora, Zambales, Bataan, Cavite, Oriental Mindoro, Occidental Mindoro, Marinduque, Romblon, Palawan, and Antique.
- **Sunday (6 July):** the rest of Ilocos Norte, Ilocos Sur, La Union, Pangasinan, Isabela, the northern portion of Aurora, Zambales, Bataan, Metro Manila, Cavite, Oriental Mindoro, Occidental Mindoro, Marinduque, Romblon, Palawan, and Antique.

HAZARDS AFFECTING COASTAL WATERS

24-Hour Sea Condition Outlook

Up to rough seas over the following coastal waters:

- Up to 3.0 m: The western seaboard of Babuyan Islands and Ilocos Norte.
- Mariners of small seacrafts, including all types of motorbancas, are advised not to venture out to sea under these conditions, especially if inexperienced or operating ill-equipped vessels.



III. Status of Displaced Population

a. Inside Evacuation Center

There are **four (4) families** or **18 persons** currently taking temporary shelter at the **Brgy. Hall of Brgy. Rajal Centro in Santa Rosa, Nueva Ecija** (see Annex B).

b. Outside Evacuation Center

There are **1,016 families** or **3,000 persons** temporarily staying with their relatives or friends (see Annex C).

c. Total Displaced Population

There are **1,020 families** or **3,018 persons** still displaced in **Regions III** and **CAR** (see Annex D).

IV. Damaged Houses

One (1) house was totally damaged in **Brgy. Patrocinio (Poblacion), San Narciso, Zambales** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱183,173.57** worth of assistance was provided by the **Local Government Units (LGUs)** to the affected families (see Annex F).

a. Standby Funds

- ₱93.82 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱15 million available at DSWD Field Offices (FOs) I, II, III, CALABARZON, and CAR.

- ₱33 million available in other DSWD FOs, which may support the relief needs of the families affected by the effects of Southwest Monsoon and TD "Bising" through inter-FO augmentation.

04 July 2025	<ul style="list-style-type: none"> DSWD FO I closely monitored the track, movement, and possible effects of the current weather disturbance through DOST-PAGASA and in coordination with the Regional Disaster Risk Reduction and Management Council (RDRRC) I, Provincial Disaster Risk Reduction and Management Councils (PDRRCs), and the Provincial Social Welfare and Development Offices (PSWDOs). DSWD FO I attended the TD "Bising" and Southwest Monsoon conducted RDRRC.
02-03 July 2025	<ul style="list-style-type: none"> DSWD FO I attended the PDRA via zoom with the following highlights: <ul style="list-style-type: none"> 2-3 Tropical Cyclones were expected to be experienced for July The LPA inside the PAR being monitored has a high chance of developing into a Tropical Depression within the next 24 hours. Likewise, raising of Tropical Cyclone Wind Signal (TCWS) is possible in the province of Ilocos Norte. All four provinces are in WHITE alert status. DSWD FO I staff were on standby for possible activation of the DSWD FO I Emergency Operations Center (EOC). Likewise, DSWD FO I Incident Management Team (IMT) members are ready for response operations to areas most likely to be affected, if necessary.

03-04 July 2025	<ul style="list-style-type: none"> DSWD FO II Regional Director Lucia Suyu-Alan, attended a radio interview to provide updates on the preparedness measures for the potential impacts of TD "Bising" and Southwest Monsoon. DSWD FO II closely coordinated with the Social Welfare and Development Teams (SWADTs) and City/Municipal Action Teams (C/MATs) to monitor their area of responsibility (AOR) in the event of untoward incidents. DSWD FO II maintained close monitoring of the potential impacts of the prevailing Southwest Monsoon and LPA in coordination with the Provincial / City / Municipal Social Welfare and Development Offices (P/C/MSWDOs) and Provincial / City / Municipal Disaster Risk Reduction Management Offices (P/C/MDRRMOs). DSWD FO II ensured the availability of prepositioned goods and continuously monitored their status to support immediate relief operations as needed. All Regional / Provincial / Municipal Quick Response Team (R/P/C/M QRTs) were on standby and on-call/alert in the event of untoward incidents.
02 July 2025	<ul style="list-style-type: none"> DSWD FO II attended the PDRA meeting spearheaded by the Office of the Civil Defense, highlighting response strategies, available resources, and coordination mechanisms.

DSWD FO III

04 July 2025	<ul style="list-style-type: none"> DSWD FO III, through its Disaster Response Management Division (DRMD), closely coordinated with the affected LGUs for significant disaster updates. DSWD FO III attended the PDRA meeting conducted by Regional Disaster Risk Reduction and Management Council (RDRRMC) III. DSWD FO III activated the Rapid Deployment Team and the SWAD Offices in the affected Provinces.

DSWD FO CALABARZON

03 July 2025	<ul style="list-style-type: none"> DSWD FO CALABARZON closely coordinated with RDRRMC, Local Disaster Risk Reduction Management Offices (LDRRMOs), and Local Social Welfare and Development Offices (LSWDOs) for significant disaster updates. DSWD FO CALABARZON EOC is still on heightened alert status for the 24/7 monitoring of weather advisories, hazard alerts, and significant disaster updates. All QRTs closely monitored their AOR in the event of untoward incidents. DSWD FO CALABARZON ensured the availability of prepositioned goods and continuously monitored their status to support immediate relief operations as needed. DSWD FO CALABARZON advised the LGUs to conduct an inspection and quality check of prepositioned FFPs. DSWD FO CALABARZON reminded all members of the Committee on Disaster Response and Early Recovery to ensure that members and emergency equipment are on standby and ready for deployment.

04 July 2025	<ul style="list-style-type: none"> DSWD FO CAR deployed a composite team from the SWAD Benguet and FO QRT to monitor the incident site in Virac, Itogon, Benguet DSWD FO CAR QRT Charlie and QRT Bravo were activated for duty to actively monitor the effects of the weather. DSWD FO CAR maintained close coordination with the Cordillera Regional Disaster Risk Reduction Council (RDRRMC) through participation in the Virtual EOC. DSWD FO CAR conducted a needs assessment for the affected population.
03 July 2025	<ul style="list-style-type: none"> DSWD FO CAR attended the PDRA meeting with the Cordillera RDRRMC regarding the Possible Effects of LPA in CAR. DSWD FO CAR maintained close coordination with the P/C/MSWDOs and P/C/MDRRMOs. DSWD FO CAR ensured the availability and adequate supply of food and non-food resources at the DSWD CAR Regional and Satellite warehouses. DSWD FO CAR DRMD QRT and SWAD Offices were on standby for possible activation. DSWD FO CAR coordinated with volunteers and service providers for workforce support across the satellite and regional warehouses.
