

DSWD DROMIC Report #5 on the Effects of Southwest Monsoon and Tropical Depression “Bising” as of 06 July 2025, 6AM

I. Situation Overview

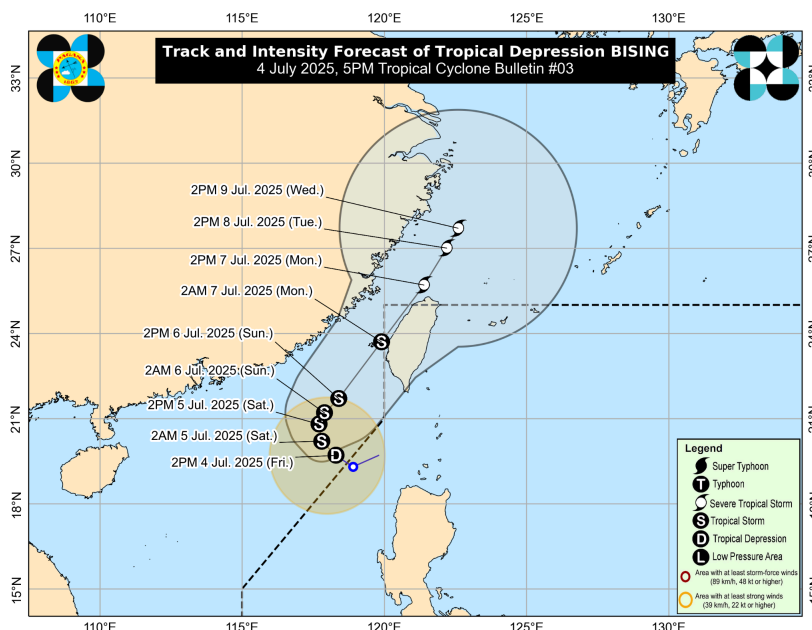
Issued on 04 July 2025, at 5:00 PM, “**Bising**” has exited the Philippine Area of Responsibility (PAR).

HAZARDS AFFECTING LAND AREAS

Heavy Rainfall Outlook

Refer to the Weather Advisory issued No. 11 at 5:00 PM today for the heavy rainfall outlook due to Tropical Depression (TD) “Bising” and the Southwest Monsoon.

Severe Winds



The Southwest Monsoon and the periphery of Bising will also bring strong to gale-force gusts over the following areas (especially in coastal and upland areas exposed to winds):

- **Today (4 July):** Ilocos Region, Isabela, the northern portion of Aurora, Zambales, Occidental Mindoro, Marinduque, Romblon, Palawan, and Antique.
- **Tomorrow (5 July):** the rest of Ilocos Norte, Ilocos Sur, La Union, Pangasinan, Isabela, the northern portion of Aurora, Zambales, Bataan, Cavite, Oriental Mindoro, Occidental Mindoro, Marinduque, Romblon, Palawan, and Antique.
- **Sunday (6 July):** the rest of Ilocos Norte, Ilocos Sur, La Union, Pangasinan, Isabela, the northern portion of Aurora, Zambales, Bataan, Metro Manila, Cavite, Oriental Mindoro, Occidental Mindoro, Marinduque, Romblon, Palawan, and Antique.

HAZARDS AFFECTING COASTAL WATERS

24-Hour Sea Condition Outlook

Up to rough seas over the following coastal waters:

- Up to 3.0 m: The western seaboard of Babuyan Islands and Ilocos Norte.
- Mariners of small seacrafts, including all types of motorbancas, are advised not to venture out to sea under these conditions, especially if inexperienced or operating ill-equipped vessels.

Up to moderate seas over the following coastal waters:

- Up to 2.5 m: The northwestern seaboard of Ilocos Sur and the seaboard of Batanes.
- Up to 2.0 m: The western seaboards of La Union and Pangasinan, the remaining seaboard of Ilocos Sur.
- Mariners of motorbancas and similarly-sized vessels are advised to take precautionary measures while venturing out to sea and, if possible, avoid navigation under these conditions.

TRACK AND INTENSITY OUTLOOK

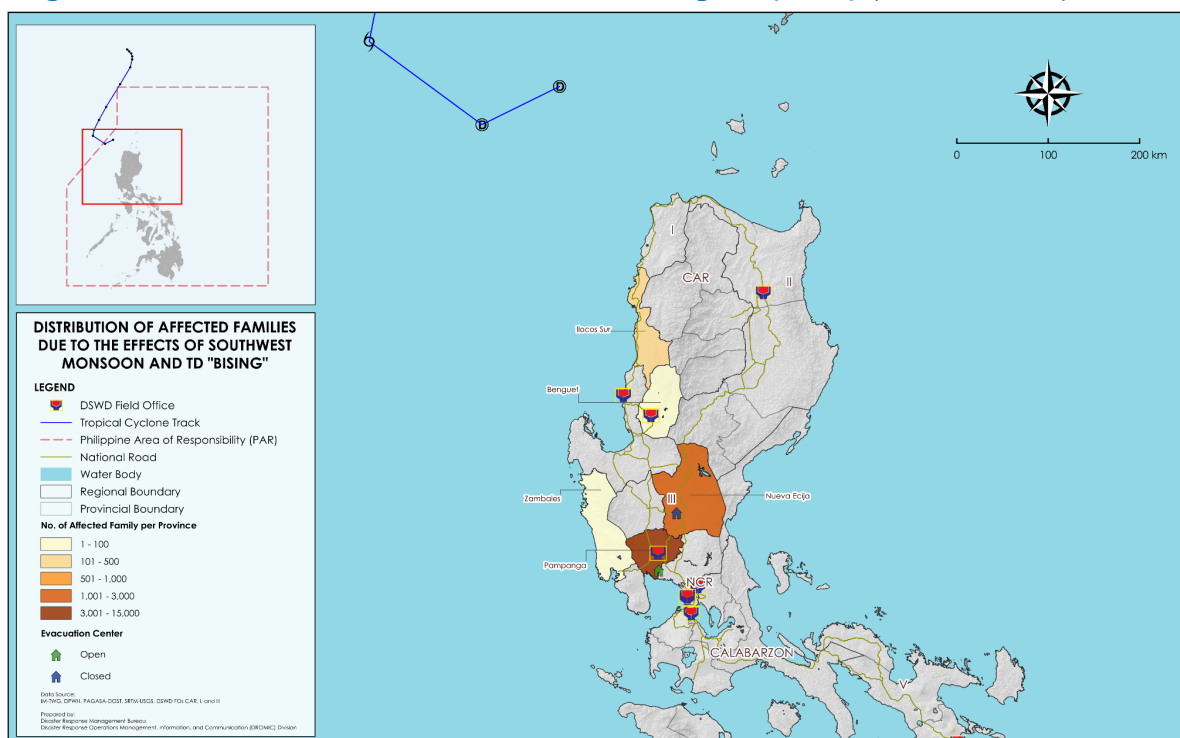
- Tropical Storm “Bising” is forecast to move north northwestward tonight through tomorrow morning before turning north northeastward over the sea west of Extreme Northern Luzon. Re-entry to the western boundary of the PAR is possible by Monday (07 July) early morning and it may exit again the northern boundary of PAR on Monday afternoon.
- “Bising” intensified into a tropical storm at 8:00 PM today. Further intensification is possible and it may reach severe tropical storm category by Sunday (06 July).

The center of Tropical Depression BISING was estimated based on all available data at 345 km West Northwest of Calayan, Cagayan (19.7°N, 118.2°E).

II. Status of Affected Areas and Population

A total of **15,685 families** or **49,491 persons** are affected in **34 barangays** in **Regions I, III** and **Cordillera Administrative Region (CAR)** (see Annex A).



III. Status of Displaced Population

a. Inside Evacuation Center

There are **two (2) families** or **nine (9) persons** currently taking temporary shelter in **two (2) evacuation centers** in **Region III** (see Annex B).

b. Outside Evacuation Center

There are **1,017 families** or **3,002 persons** temporarily staying with their relatives or friends (see Annex C).

c. Total Displaced Population

There are **1,019 families** or **3,011 persons** still displaced in **Regions III** and **CAR** (see Annex D).

IV. Damaged Houses

A total of **13 houses** were damaged, of which, **one (1)** is **totally damaged** and **12** are **partially damaged** in **Regions III** and **CAR** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱352,891.02** worth of assistance was provided to the affected families; of which, **₱169,717.45** from **DSWD** and **₱183,173.57** from the **Local Government Unit (LGU)** (see Annex F).
