

DSWD DROMIC Report #7 on the Effects of Southwest Monsoon and Typhoon "Bising"

as of 07 July 2025, 6AM

I. Situation Overview

Issued on 07 July 2025, at 5:00 AM, "**Bising**" slightly weakens as it moves over the Northwestern portion of Taiwan.

Severe Winds

The southwest monsoon will bring strong to gale-force gusts over the following areas (especially in coastal and upland areas exposed to winds):

- Today (7 July): Ilocos Region, Cagayan, Isabela, Aurora, Zambales, Bataan, Quezon, Occidental Mindoro, Masbate, and Romblon;
- Tomorrow (8 July): Ilocos Region, Cagayan, Isabela, Aurora, Zambales, Bataan, Quezon, Masbate, Romblon, Occidental Mindoro, and Palawan; and
- **Wednesday (9 July):** Ilocos Region, Cagayan, Aurora, Zambales, Bataan, Quezon, Masbate, Romblon, Occidental Mindoro, and Palawan.

HAZARDS AFFECTING COASTAL WATERS

24-Hour Sea Condition Outlook

Moderate to rough seas over the following coastal waters:

- Up to 4.0 m: The seaboard of Batanes and the western and northern seaboards of Babuyan Islands.
- Up to 3.0 m: The western seaboard of llocos Norte.
- Mariners of small seacrafts, including all types of motorbancas, are advised not to venture out to sea under these conditions, especially if inexperienced or operating ill-equipped vessels.



Up to moderate seas over the following coastal waters:

- Up to 2.5 m: The seaboard of Zambales, and the remaining seaboards of Ilocos Region and Babuyan Islands.
- Up to 2.0 m: The seaboards of Bataan and Lubang Islands.
- Mariners of motorbancas and similarly-sized vessels are advised to take precautionary measures while venturing out to sea and, if possible, avoid navigation under these conditions.

TRACK AND INTENSITY OUTLOOK

- Typhoon BISING entered the Philippine Area of Responsibility (PAR) at 11:00 PM yesterday and made landfall over the southwestern portion of Taiwan at 11:50 PM yesterday. BISING will continue moving generally northeastward while traversing the landmass of Taiwan. It will exit the northern boundary of the PAR this morning. On the forecast track, BISING will turn northwestward tomorrow and will make another landfall over Eastern China.
- BISING will continue to weaken throughout the forecast period and will become a remnant low by Wednesday (9 July) as it moves over the landmass of Eastern China.

The center of the eye of Typhoon BISING was estimated based on all available data at 405 km North Northwest of Itbayat, Batanes (24.3 °N, 120.8 °E) while moving Northeastward at 25 km/h with maximum sustained winds of 130 km/h near the center and gustiness of up to 180 km/h.


II. Status of Affected Areas and Population

A total of **27,401 families** or **82,548 persons** are affected in **55 barangays** in **Regions I, III** and **Cordillera Administrative Region (CAR)** (see Annex A).









III. Status of Displaced Population

a. Inside Evacuation Center

There are two (2) families or nine (9) persons currently taking temporary shelter in two (2) evacuation centers in Region III (see Annex B).

b. Outside Evacuation Center

There are **1,017 families** or **3,002 persons** temporarily staying with their relatives or friends (see Annex D).

c. Total Displaced Population

There are **1,019 families** or **3,011 persons** still displaced in **Regions III** and **CAR** (see Annex E).

IV. Damaged Houses

A total of **15 houses** were damaged, of which, **three (3)** are totally **damaged** and **12** are **partially damaged** in **Regions III** and **CAR** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of ₱687,569.52 worth of assistance was provided to the affected families; of which, ₱504,395.95 from DSWD and ₱183,173.57 from the Local Government Units (LGUs) (see Annex G).
