

DSWD DROMIC Report #8 on the Effects of Southwest Monsoon and Typhoon “Bising” as of 07 July 2025, 6PM

I. Situation Overview

Issued on 07 July 2025, at 11:00 AM, “**Bising**” exited the Philippine Area of Responsibility (PAR).

HAZARDS AFFECTING LAND AREAS

Heavy Rainfall Outlook

Refer to Weather Advisory issued No. 5 at 11:00 AM today for the heavy rainfall outlook due to the Southwest Monsoon.

Severe Winds

The Southwest Monsoon will bring strong to gale-force gusts over the following areas (especially in coastal and upland areas exposed to winds):

- **Today (7 July):** Ilocos Region, Cagayan, Isabela, Aurora, Zambales, Bataan, Quezon, Occidental Mindoro, Masbate, and Romblon
- **Tomorrow (8 July):** Ilocos Region, Cagayan, Isabela, Aurora, Zambales, Bataan, Quezon, Masbate, Romblon, Occidental Mindoro, and Palawan.
- **Wednesday (9 July):** Ilocos Region, Cagayan, Aurora, Zambales, Bataan, Quezon, Masbate, Romblon, Occidental Mindoro, and Palawan.

HAZARDS AFFECTING COASTAL WATERS

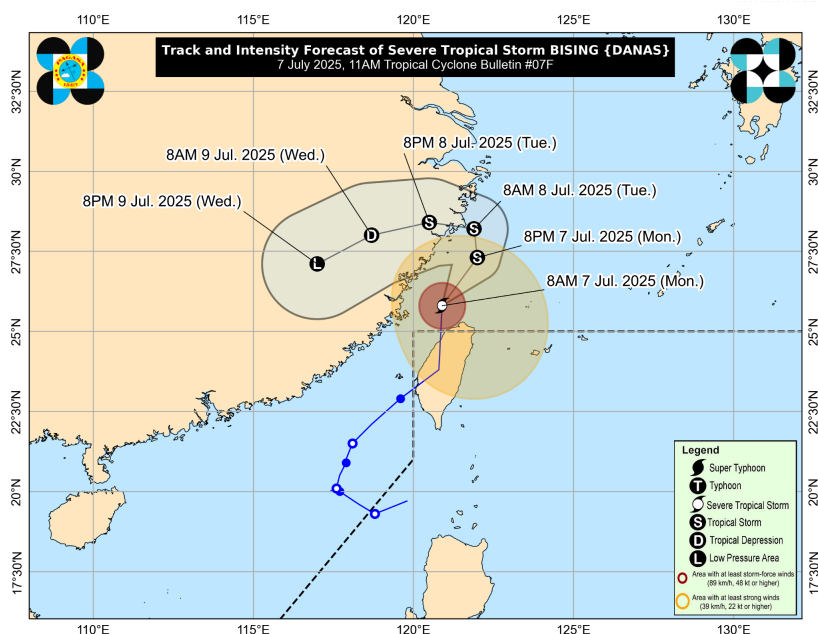
24-Hour Sea Condition Outlook

Moderate to rough seas over the following coastal waters:

- Up to 3.0 m: The seaboard of Batanes and the western and northern seaboards of Babuyan Islands and Ilocos Norte.
- Mariners of small seacrafts, including all types of motorbancas, are advised not to venture out to sea under these conditions, especially if inexperienced or operating ill-equipped vessels.

Up to moderate seas over the following coastal waters:

- Up to 2.5 m: The seaboard of Zambales, and the remaining seaboards of Ilocos Region and Babuyan Islands.



- Up to 2.0 m: The seaboard of Bataan and Lubang Islands.
- Mariners of motorbancas and similarly-sized vessels are advised to take precautionary measures while venturing out to sea and, if possible, avoid navigation under these conditions.

TRACK AND INTENSITY OUTLOOK

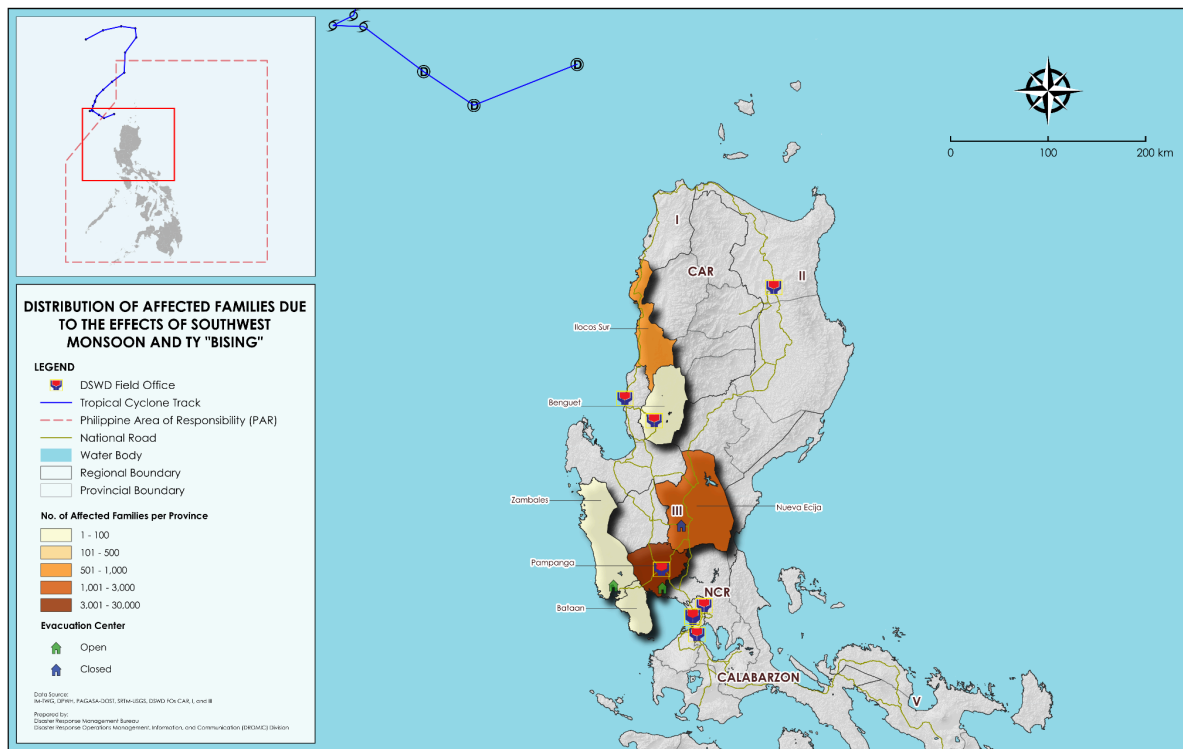
- BISING has exited the PAR at 5:00 AM today. On the forecast track, it will move north northeastward over the next 12 hours before turning northward over the East China Sea by tomorrow (08 July) morning. By tomorrow afternoon, it is forecast to turn generally westward, making landfall over the Eastern China region. It will continue to move west southwestward until it becomes a remnant low by Wednesday (09 July).
- BISING will continue to weaken over the East China Sea due to unfavorable conditions. It is forecast to weaken into a remnant low by Wednesday (9 July) as it moves over the landmass of Eastern China.

The center of the eye of Typhoon Bising was estimated based on all available data at 605 km North of Itbayat, Batanes (OUTSIDE PAR) (26.2 °N, 121.2 °E) while moving Northward at 35 km/h with maximum sustained winds of 100 km/h near the center and gustiness of up to 125 km/h

II. Status of Affected Areas and Population

A total of **30,596 families** or **95,867 persons** are affected in **61 barangays** in **Regions I, III** and **Cordillera Administrative Region (CAR)** (see Annex A).



III. Status of Displaced Population

a. Inside Evacuation Center

There are **two (2) families** or **nine (9) persons** currently taking temporary shelter in **two (2) evacuation centers** in **Region III** (see Annex B).

b. Outside Evacuation Center

There are **1,018 families** or **3,005 persons** temporarily staying with their relatives or friends (see Annex D).

c. Total Displaced Population

There are **1,020 families** or **3,014 persons** still displaced in **Regions III** and **CAR** (see Annex E).

IV. Damaged Houses

A total of **17 houses** were damaged, of which, **four (4)** are **totally damaged** and **13** are **partially damaged** in **Regions III** and **CAR** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of **₱687,931.52** worth of assistance was provided to the affected families; of which, **₱504,395.95** from **DSWD** and **₱183,535.57** from the **Local Government Units (LGUs)** (see Annex G).
