

DSWD DROMIC Report #9 on the Effects of Southwest Monsoon and Typhoon "Bising"

as of 08 July 2025, 6AM

I. Situation Overview

On 04 July 2025, at 5:00 AM, the Low Pressure Area (LPA) west of Calayan, Cagayan developed into a Tropical Depression and was named "Bising". Meanwhile, the Southwest Monsoon affected Central and Southern Luzon, Visayas and Mindanao. By 11:00 AM, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) reported that it slightly intensified over the sea west of extreme Northern Luzon. At 3:00 PM, Tropical Depression "Bising" has exited the Philippine Area of Responsibility (PAR). It continuously intensified and affected the extreme Northern Luzon.


On 06 July 2025, at 4:00 AM, PAGASA reported that the trough of Severe Tropical Storm "Bising" affected extreme Northern Luzon while Southwest Monsoon affected the rest of the country. By 5:00 PM, Typhoon "Bising" accelerated northeastward towards Taiwan. By 11:00 PM, it further intensified and re-entered the northwestern boundary of the PAR.

On 07 July 2025, at 5:00 AM, Typhoon "Bising" slightly weakened as it moved over the northwestern portion of Taiwan. Meanwhile, the Southwest Monsoon continued to affect the rest of the country. At 11:00 AM, BISING exited the PAR.

II. Status of Affected Areas and Population

A total of **30,683 families** or **95,910 persons** are affected in **61 barangays** in **Regions I, III**, and **Cordillera Administrative Region (CAR)** (see Annex A).





III. Status of Displaced Population

a. Inside Evacuation Center

There are two (2) families or nine (9) persons currently taking temporary shelter in two (2) evacuation centers in Region III (see Annex B).

b. Outside Evacuation Center

There are **1,022 families** or **3,026 persons** temporarily staying with their relatives or friends (see Annex D).

c. Total Displaced Population

There are **1,024 families** or **3,035 persons** still displaced in **Regions III** and **CAR** (see Annex E).

IV. Damaged Houses

A total of **17 houses** were damaged in **Regions I**, **III**, and **CAR**; of which, **four (4)** were **totally damaged** and **13** were **partially damaged** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of ₱909,411.43 worth of assistance was provided to the affected families; of which, ₱725,875.86 from DSWD and ₱183,535.57 from the Local Government Units (LGUs) (see Annex G).

1. Standby Funds

- ₱93.82 million Quick Response Fund (QRF) available at the DSWD Central Office.
- ₱15 million available at DSWD Field Offices (FOs) I, II, III, CALABARZON, and CAR.
- ₱33 million available in other DSWD FOs, which may support the relief needs of the families affected by the effects of Southwest Monsoon and Typhoon "Bising" through inter-FO augmentation.

04 July 2025	 The DRMB spearheaded the Climate Outlook Forum with DSWD FOs to provide an update on the track, movement, and possible effects of Typhoon "Bising".

Lanada, Ph.D. reaffirmed DSWD's commitment to providing timely and effective social protection interventions to communities that may be affected by potential flooding and displacement due to Southwest Monsoon and Typhoon "Bising", formerly Low Pressure Area (LPA 6h).

07 July 2025	 DSWD FO I closely coordinated with the Social Welfare and Development Teams (SWADTs) and City/Municipal Action Teams (C/MATs) to monitor their respective areas of responsibility (AORs) in the event of any untoward incidents.
04 July 2025	 DSWD FO I closely monitored the track, movement, and possible effects of the current weather disturbance through DOST-PAGASA and in coordination with the Regional Disaster Risk Reduction and Management Council (RDRRMC) I, Provincial Disaster Risk Reduction and Management Councils (PDRRMCs), and the Provincial Social Welfare and Development Offices (PSWDOs). DSWD FO I attended the PDRA on the Typhoon "Bising" and Southwest Monsoon conducted by the RDRRMC I.
02-03 July 2025	 DSWD FO I attended the virtual PDRA with the following highlights: 2-3 Tropical Cyclones are expected to be experienced in July 2025 The LPA inside the PAR being monitored has a high chance of developing into a Tropical Depression within the next 24 hours. Likewise, raising of Tropical Cyclone Wind Signal (TCWS) is possible in the province of Ilocos Norte. All four provinces are in WHITE alert status. DSWD FO I staff were on standby for possible activation of the DSWD FO I Emergency Operations Center (EOC). Likewise, DSWD FO I Incident Management Team (IMT) members are ready for response operations to areas most likely to be affected, if necessary.



DSWD FO II

03-04 July 2025	 DSWD FO II Regional Director Lucia Suyu-Alan, attended a radio interview to provide updates on the preparedness measures for the potential impacts of Typhoon "Bising" and Southwest Monsoon. DSWD FO II closely coordinated with the SWADTs and C/MATs to monitor their respective AORs in the event of any untoward incidents. DSWD FO II maintained close monitoring of the potential impacts of the prevailing Southwest Monsoon and LPA in coordination with the Local Social Welfare and Development Offices (LSWDOs) and Local Disaster Risk Reduction and Management Offices (LDRRMOs). DSWD FO II ensured the availability of prepositioned goods and continuously monitored their status to support immediate relief operations as needed. All Regional / Provincial / Municipal (R/P/C/M) QRTs were on standby and on-call/alert in the event of untoward incidents.
02 July 2025	 DSWD FO II attended the PDRA meeting spearheaded by the Office of the Civil Defense (OCD), highlighting response strategies, available resources, and coordination mechanisms.

DSWD FO III

04 July 2025	 DSWD FO III attended the PDRA meeting conducted by RDRRMC III. DSWD FO III activated the Rapid Deployment Team and the SWAD Offices in the affected Provinces.

DSWD FO CALABARZON

03 July 2025	 DSWD FO CALABARZON closely coordinated with RDRRMC, LDRRMOs, and LSWDOs for any significant disaster updates. DSWD FO CALABARZON EOC remained on heightened alert status for the 24/7 monitoring of weather advisories, hazard alerts, and significant disaster updates. All QRTs closely monitored their respective AORs in the event of untoward incidents. DSWD FO CALABARZON ensured the availability of prepositioned goods and continuously monitored their status to support immediate relief operations as needed. DSWD FO CALABARZON advised the LGUs to conduct an inspection and quality check of prepositioned FFPs. DSWD FO CALABARZON reminded all members of the Committee on Disaster Response and Early Recovery to ensure that members and emergency equipment are on standby and ready for deployment.

DSWD FO CAR ensured the availability and adequate supply of food and non-food resources at the DSWD FO CAR Regional and Satellite warehouses. DSWD FO CAR DRMD QRT and SWAD Offices were on standby for possible activation. DSWD FO CAR coordinated with volunteers and service providers for workforce support across the satellite and regional warehouses.
