

# DSWD DROMIC Report on the Fire Incident in Brgy. Balud I, Zarraga, Iloilo

08 July 2025, 6AM

## I. Situation Overview

On 25 June 2025 at around 7:13 AM, a fire broke out in Brgy. Balud I, Zarraga, Iloilo. The Bureau of Fire Protection (BFP) responded to the scene and extinguished the fire at around 8:00 AM. The fire gutted a house, displacing a family who immediately sought temporary shelter with relatives while exploring viable options to reconstruct their damaged home.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in Region VI, provided relief assistance to address the immediate needs of the affected family.

One (1) house was totally damaged in Brgy. Balud I, Zarraga, Iloilo (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱10,454.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
